(Note 2) For interbank remittance amount (made through cash payment method) exceeding NT\$2 million, for each addition of NT\$1 million, a charge of NT\$30 is additionally collected. For a remittance amount less than NT\$1 million, it is counted as NT\$1 million for the service charge.

(Note 3) For interbank remittance (made through account transfer) amount exceeding NT\$1 million, for each addition of NT\$1 million, a charge of NT\$10 is additionally collected.

(Note 4) For interbank remittance amount exceeding NT\$1 million for each addition of NT\$1 million, a charge of NT\$10 is additionally collected. The maximum service charge of each remittance is NT\$110, and there is no limitation on the maximum remittance amount.

(Note 5) The maximum remittance amount of each interbank remittance is NT\$50 million for a remittance amount exceeding NT\$50 million, it is required to make remittance from other branch; however, only one remittance application form is required. Each application form amount shall not exceed the maximum amount of NT\$ 2 billion, and it is remitted outward by separately based on the unit of NT\$50 million by our bank. The service charge for currency exchange is collected separately according to the service charge collection standard of our bank.

(Note 6) For interbank transfer amount exceeding NT2 million, for each addition of NT\$1 million, a charge of NT\$10 is additionally collected. For a remittance amount less than NT\$1 million, it is counted as NT\$1 million for the service charge. The maximum transfer amount of each transaction is NT\$ 50 million.
