Communication Status of Independent Directors with Internal Audit Officer and Certified Public Account

- 1. After the internal audit report of the Bank is reported to the Chairman for review, it is submitted to the Audit Committee and independent directors for review according to regulations. In case of discovery of material deficiencies or abnormalities, report to the single reporting window of the Financial Examination Bureau, Financial Supervisory Commission according to the format and content specified by the competent authority. The external audit examination comment improvement status is submitted to the independent directors during the board of directors' meeting. For the parts required for improvement as listed in the examination report, all of the independent directors actively perform the supervision and tracking. The Chief Audit Officer of the Bank reports the audit duty execution status to the board of directors and audit committee quarterly. The independent directors maintain close contact with the internal audit managers.
- 2. The directors and independent directors of the Bank conduct discussion meeting with the internal auditors periodically on the deficiencies of the internal control system, and the discussion meeting records are reported to the board of directors' meeting, such that the communication status is proper.
