

## Chang Hwa Commercial Bank, Ltd.

Notice for the 2020 Annual Meeting of Shareholders

(Summary Translation)

The 2020 Annual General Shareholders' Meeting (the "Meeting") of Chang Hwa Commercial Bank, Ltd. (the "Company") will be convened in CHB's Headquarters (No. 57, Sec. 2, Zhongshan N. Rd., Taipei City, Taiwan.) at 9:00 a.m. on Friday, June 19, 2020.

## A. The agenda for the Meeting is as follows:

- (a) Report Items:
  - 1. 2019 Business Report.
  - 2. Audit Committee review of 2019 audited Financial Statements.
  - 3. 2019 employee and director remuneration distribution status.
- (b) Recognition Items:
  - 1. The Company's 2019 Business Report and Financial Statements.
  - 2. The Company's distribution of 2019 profit.
- (c) Discussion and Election Items:
  - 1. The issuance of new shares via capitalization of earnings.
  - 2. The amendment of the Company's Articles of Incorporation.
  - 3. Election of 26th term of the Company's Directors (including Independent Directors).
  - 4. The release of non-competition restrictions for the Company's directors (including Independent Directors) of the 26th term.

## (d) Questions and Motions

In accordance with Article 172 of the Company Act, Article 26-1 of the Securities and

Exchange Act, and other relevant regulations, the main content of the Meeting have been uploaded to Market Observation Post System (website: http://emops.twse.com.tw; Enquiry path: basic information / electronic book / Shareholders' meetings), please download it yourself for reference. (Stock Code: 2801)

- B. The 2019 profits of the Company proposed by the Board of Directors to be distributed as follows:
  - (a) Cash dividends: NT\$0.4 per share; the aggregate amount of cash dividends is NT\$3,994,124,464.
  - (b) Stock dividends: NT\$ 0.4 per share; the aggregate amount of stock dividends is NT\$ 3,994,124,460.
- C. The entries in the shareholders' register book for share transfer shall be suspended from April 21, 2020 to June 19, 2020 pursuant to Company Act.
- D. If there is any shareholder who wishes to solicit proxies from other shareholders, the Company will publish the information of such solicitation in the website of Securities and Futures Institute on May 19, 2020. Shareholders who wish to obtain such information may visit the website <a href="http://free.sfi.org.tw">http://free.sfi.org.tw</a> by clicking "Get Page" and then entering relevant search conditions (Stock Code: 2801).
- E. Shareholders may choose the electronic voting system to exercise their voting. The voting period is from May 20, 2020 to June 16, 2020. Shareholders may login to "AGM E-Voting Platform" from TDCC website and follow the related instructions (<a href="http://www.stockvote.com.tw">http://www.stockvote.com.tw</a>).
