In consideration of your endorsing/countersigning this Bills of Lading/Air Transportation Waybill/Parcel Post Receipt to enable me/us to take delivery of the goods mentioned below, I/we hereby guarantee to hold you harmless from any consequences and to indemnify you against all losses and/or damages and/or commission and charges which may arise from your so doing.

I/We agree that once you have endorsed/countersigned the Letter of Guarantee/Bills of Lading/Air Transportation Waybill/Parcel Post Receipt (as the case may be), I/we are disclaimed our right to reject related documents which contain irregularity(ies)/discrepancy(ies) despite I/we have finally make use of the endorsed/countersigned Letter of Guarantee/Bills of Lading/Air Transportation Waybill/Parcel Post Receipt (as the case may be) or not and you have the absolute power to make payment under the discrepant documents without prior notice to me/us.

The counter-guarantee hereby applied for is subject to all the terms and conditions contained in the General Security Agreement Relating to Goods or the Trade Financing General Agreement (as the case may be) heretofore executed by me/us and delivered to you.

If you elect for the counter-guarantee to be issued by a correspondent bank, then you shall have the complete discretion in selecting such correspondent bank and we confirm that the indemnities granted by me/us to you under the General Agreement by customer(s), the General Security Agreement Relating to Goods, the Trade Financing General Agreement and all other agreements entered into by me/us in your favour shall be extended to indemnify you against all actions, claims, demands, liabilities, losses, damages, costs, charges, and expenses of whatever nature which you may sustain, suffer or incur, including any liability to the correspondent bank, in connection with or arising in any way out of the Counter-guarantee.
